You can also receive temporary residence permit if you cannot leave Lithuania due to serious health problems; you became a victim of human trafficking; you are a foreigner who has completed studies in Lithuania or a researcher who has completed research and experimental development work. A temporary residence permit for person who has the right to reinstate Lithuanian citizenship or person who is of Lithuanian descent is usually issued for 5 years, in other cases for 1 year.
